In a recent review of VCHCP's prescription medication costs and utilization for the first 2 quarters of 2010 by Express-Scripts, our Pharmacy Benefit Manager, it was pointed out that the percent of generic drugs prescribed by our physicians increased from 76% to over 78%. This compares to a 72% average for all their clients. The 2% increase amounted to a savings to VCHCP in excess of \$82,000!

HPV vaccine has recently been approved by ACIP for use in males 9 - 26 years old. However, ACIP has not recommended the vaccine for general use in this population. The Plan's Utilization Management Committee has approved the policy that the Plan will not cover HPV Vaccine for routine immunization of males 9 - 26 years old. The vaccine will be approved for those members who are at high risk of complications from the Human Papillomavirus. For more information, please see the MMWR Weekly Report of May 28, 2010.

Recommendations for Pertussis Vaccinations Broadened

The California Department of Public Health (CDPH) has broadened its recommendations for who should be vaccinated for pertussis (whooping cough) in an effort to curb the spread of the disease. The CDPH is now recommending that adults over age 64 get vaccinated along with women of child-bearing age and anyone who may have contact with a pregnant women or infant. "We are urging health providers to broaden their use of the pertussis vaccine and we are urging Californians to take the simple step of getting vaccinated to prevent pertussis," said the CDPH's Gilberto Chavez, MD.

The CDPH declared whooping cough an epidemic in the state in June of 2010 and has recorded 1,496 cases as of July 13.

Drugs in the News

Drugs New to VCHCP Step Therapy Program

Because of the increasingly high cost of Brandname drugs and availability of generic alternatives, the following drugs now have a Step Therapy requirement:

Class	Brand	Generic Alt.
Nasal Steroids	Nasonex fluticasone spray	
Sed. Hypnotics	Lunesta Ambien CR	zolpidem, <u>or</u> zaleplon
Anti-Diabetics	Actos, Avandia Exubera	metformin <u>or</u> sulfonylureas

Acne Drug Solodyn Now Requires Prior Auth

Solodyn, of the drug class Tetracycline, is an extended release form of the generic minocycline hydrochloride, which is used to treat bacterial infection, including acne. However, it is not recommended for use as a "first line" therapy, and will only be approved by VCHCP after the patient has failed a 90-day period of treatment using generic minocycline.

First Generic To Lovenox Available

Aug. 17, 2010 – Last month U.S. Food and Drug Administration (FDA) approved the first generic to sanofi-aventis' Lovenox(r) (enoxaparin sodium), an injectable anti-coagulant commonly used to prevent deep vein thrombosis (DVTs). FDA has determined that this drug is interchangeable with brand Lovenox. The generic was developed under a collaboration agreement between Sandoz and Momenta. According to Sandoz, shipments of its generic enoxaparin have already begun. Pricing information is not known at this time.

Boxed Warning Added to Plavix's LabelA new boxed warning has been added to the

prescribing information for Plavix(r) (clopidogrel). The boxed warning alerts patients and healthcare professionals that people who are poor metabolizers cannot effectively convert Plavix to its active form. As a result, patients may not receive the full benefit of the platelet inhibitor and may remain at risk for heart attack, stroke and cardiovascular death.

Second "Triptan" To Lose Patent Protection

Amerge (naratriptan) joins Imitrex as now available in generic form. Amerge is approved for the acute treatment of migraine attacks with or without aura in adults. The generics are now available as 1mg and 2.5mg tablets.
